**Tuition is based on a yearly rate (not monthly) for 32 classes.  
Families have three options to make payments for their tuition:**

- Registration Fee & Annual payment in Full upon Registration (\$10 SERVICE CHARGE IF USING A CREDIT CARD)
- Registration Fee & Tuition Deposit paid today & yearly balance broken up into Nine (9) additional  
monthly payments automatically debited from your checking account starting September 1<sup>st</sup> 2022.  
All payments must be completed and paid in full by May.
- Registration Fee & Tuition Deposit paid today & yearly balance broken up into Nine additional  
monthly payments by cash or check. This option is only available with a backup credit card which  
will be charged on the 7th of the month at 7:00pm, if payment has not been received. A \$10.00  
late fee will also apply. Credit cards that are denied will incur an additional \$25.00 fee.

**I understand that the classes are being monitored by a security webcam system, viewable by Howell  
Academy staff, to ensure the best dance education for my child/children.**

**Withdrawals**

Students will stay on the class roster for the entire season unless a child withdraws from the class. If your child is

Tuition will cease on the first of the month following the date of the formal withdrawal through November 30th.
